A Statement by the International Federation of Women Lawyers (FIDA) on March 8, 2025, International Women's Day

The 2025 International Women's Day holds a particular significance as we mark the 30th anniversary of the Beijing Declaration and Platform for Action, alongside the 25th anniversary of the United Nations Security Council Resolution 1325 on Women, Peace, and Security, and 22 years of the Protocol to the African Charter on Human and People's Rights on the Rights of Women in Africa (Maputo Protocol). Also relevant is the Belem de Para Convention - the inter-American Convention on the Prevention, Punishment, and Eradication of Violence against Women: a landmark treaty adopted by the organization of American States (OAS) signed in 1994. These pivotal instruments established the groundwork for advancing gender equality and empowering women globally.

Only recently, during the 38th Ordinary Session of the Assembly of Heads of States and Governments of the African Union, the African Union Convention on Preventing and Combating Violence Against Women in Africa (Maputo Protocol), was adopted. We reflect on these instruments, platforms and treaties as we celebrate our achievements, and reaffirm our commitment to the work that lies ahead.

Over the past 20+ years, we have witnessed significant advancements of women's rights globally in the area of civil, political, socio-economic and cultural rights. Women have increasingly occupied leadership roles in politics and decision-making, challenging historical norms. Yet, despite these successes, we must acknowledge that many of the goals outlined in various gender equality instruments remain unfulfilled, and new challenges have emerged. We must also confront the enduring realities where, in many parts of the world, women continue to face systemic barriers, including violence, discrimination, and insufficient access to resources and decision-making.

The 2025 IWD theme, calls for accelerated action, to achieve rapid advancements in gender equality focusing on recognising strategies and tools that drive women's progress in education, employment, and leadership.
